APPLYING FOR A VISA TO FIJI

AS AT 14-FEB-2022

Kindly note that the Fijian borders opened on **01-Dec-2021** only for **fully vaccinated** travelers from **Travel Partner Countries** (*listed below*).

TRAVEL PARTNER COUNTRIES REQUIREMENTS

VISA FEES & PAYMENT DETAILS

Travelers from **non-travel-partner countries** (*not listed above*) can request entry into Fiji only if they already hold a valid permit and the purpose of their visit is one of the following:

- Medical treatment
- Wedding
- Visit a family member who is medically ill or to attend a funeral

Requirements

1. Recent passport bio data page;
2. Flight itinerary;
3. Proof of vaccination- Both doses;
4. Confirmed accommodation in Fiji after completion of quarantine (10 nights from arrival);
5. Request Letter for purpose of entry addressed to the Chair of the COVID19 Risk Mitigation Taskforce (CRMT);
6. An endorsed letter of undertaking by the traveller(s) addressed to the Chairperson of the CRMT confirming the following: • Enter mandatory 14 day quarantine at a Government designated quarantine facility; • Responsibilities the traveller(s) will take to remain COVID-safe, such as self- isolation, self-driving or ensuring a private transfer to the airport and wear appropriate Personal Protective Equipment (PPE); • If positive, adhere to the Fijian Ministry of Health and Medical Services' protocol for dealing with positive case; • Cover all cost for treatment if positive and
7. Additional documents – Medical report, wedding invitation, death certificate.

For applying for visa by travelers from **travel partner countries**, please find below the requirements.

1. (must have stayed in a travel partner country of Fiji for at least 14 consecutive days prior to travelling)
2. Duly-filled visa application form (attached);
3. Three colored passport-size photos with clear background;
4. Certified colored copy of the passport;
5. Proof of full vaccination (AstraZeneca, Pfizer, Moderna or Johnson & Johnson – last dose should be at least 14 days ago – 2 doses of sinopharm plus 1 dose of one of the aforementioned recognized vaccines can be accepted);
6. Medical travel insurance with international coverage that includes COVID-19 and covers entire stay in Fiji is required;
7. Three nights quarantine in a designated hotel is mandatory upon arrival to Fiji, so we require a copy of booking of the same. Please check this link for a list of approved hotels: <https://www.fiji.travel/covid-19/safer-than-ever>;
8. Confirmation of hotel booking (main stay) OR sponsor letter from friend or relative in Fiji (Fijian Citizen) with copy of the sponsor's passport/ID;
9. Confirmed travel itinerary including ticket details;
10. Official bank statement of the last 3 months (stamped) and
11. NOC letter from employer.

Required documents are to be submitted via courier to the following address:

The **visa application fee** is **AED400** for single-entry and **AED500** for multiple entry; also an **administrative fee of AED150** applies for both categories.
